Memorandum of Understanding for International Guest Student Program between

The Regents of the University of New Mexico, Albuquerque, N.M., U.S.A. and

Bohai University, Jinzhou, Liaoning, China

This agreement is entered into and effective as of the last date in the signature section below by andbetween theRegents of the University of New Mexico (hereinafter referred to as "UNM"), and Bohai University (hereinafter referred to as "BU"). The purpose of this agreement is to establish an International Guest Student Program ("Program") at UNM in which up to 20 BU undergraduate students who have studied at BU full-time for at least one academic year will enroll at UNM annually to take courses that will transfer back to BU and be applied toward a BUdegree.

I. Responsibilities of BU 渤海大学的职责

It is agreed that BU will recruit students for the Program in accordance with the following guidelines: 渤海大学将根据以下条款为本项目推荐学生:

- A. BU shall provide students with accurate information about UNM and the Program. 负责为学生提供关于新墨西哥大学及本项目的准确信息。
- B. BU shall provide students with UNM application and fee information, asfound on the UNM website. BU shall not charge prospective Program studentsany application, processing, handling, or other fees in connection with their application to the Program.

负责为学生提供新墨西哥大学网站公布的项目申请和收费信息。渤海大学将不以任何名义就该项目的申请和录取收取费用。

- C. BU is responsible to ensure that BU students comply with all financial requirements of UNM. 告知渤海大学学生按时支付新墨西哥大学相关的学习费用。
- D. BU is responsible for all matters pertaining to the transfer and acceptance (including all policies and processes) of UNM course credits earned by BU participantsaccording to BU degree requirements and transfer policies, and for informing BU students that they must order and pay for an official transcript upon the completion of their studies at UNM.

E.BU is responsible for assuring that students conform to the stated requirements for admission to the Program. In addition, BU will work with UNM toassess whether students have the necessary prerequisites for the courses and programs of study that students may enroll in while at UNM.

F. BU will ensure that students in the Program meet the following minimum qualifications for transfer admission into UNM:

- 1. A minimum score of 6.0 on IELTS OR a minimum score of 68 on TOEFLiBT. 本科生: 雅思至少 6.0 分或托福至少 68 分。
- 2. Submit all student application materials to UNM no later than 01 April for August admission. 如申请八月开学季,则需在四月一日前将全部学生申请材料提交至新墨西哥大学。



- G. The maximum number of students that can enroll in the Program is 20 per academic year. 合作项目录取学生上限为每学年 20 人。
- H. BU will identify an academic advisor to work with UNM staff to assure that students' UNM course work fulfills the requirements of their BU degrees.

II.Responsibilities of UNM

新墨西哥大学职责

It is agreed that UNM will be responsible for and provide the following:

新墨西哥大学同意负责并提供以下事项:

- A. Through the Program,UNMwill allow dulyadmitted BU students to take credit-bearing UNM courses for 1 or 2 semesters as study abroad students. Some courses may not be available because they are full or because the pertinent academic program accepts domestic students only. Academic credit may be transferred, subject to BU acceptance, tosatisfy degree requirements at BU. 新墨西哥大学通过本项目提供给渤海大学学生转学分课程。学生作为交流生在新墨西哥大学学习学期课程。学分可转换至渤海大学,并满足渤海大学的学位申请要求。
- B. UNM shall be solely responsible for all course-planning, organization, requirements, and administration, program development and content, instruction, and student evaluation.
- 新墨西哥大学全面负责国际交流生的课程规划、组织及管理、课程发展及内容、教学及学生评估。
- C. UNM shall provide brochures, application forms, and other promotional materials for use by BU as requested.
- 新墨西哥大学负责提供项目宣传册,入学申请表格,及其他渤海大学需要的宣传资料。
- D. UNM will have sole authority as to the acceptance of any student according to its policies, requirements and practices. Each student accepted will be expected to participate in UNM courses at the same level of proficiency as any other student enrolled at UNM.
- 新墨西哥大学有权根据相关的规定与要求决定是否录取学生。所有项目招收的学生与其他在新墨西哥 大学就读的学生适用同样的语言入学要求。
- E. UNM shall issue each BU student registered for credit programs a photoidentification card. Students are entitled to use campus facilities such as libraries, athleticfacilities, student health center, computer labs and the campus transportation system aspermitted by UNM policies.
- 负责为渤海大学的学生注册并提供学生证。根据新墨西哥大学的政策,学生有权免费使用校园设施,例如图书馆,运动设施,学生健康中心,计算机实验室和校园交通系统。
- F. UNM shall issue each accepted guest student the required documents for a J-1 visa in accordance withUNM policies and current U.S. law.U.S. law requires that any BU guest student who decides to seek a degree at UNM must leave the U.S. and then apply to enroll at UNM under an F-1 visa. 根据新墨西哥大学的政策和现行法律,新墨西哥大学应协助签发与J-1签证有关的文件。美国法律要求若渤海大学交流项目学生希望寻求新墨西哥大学学位,则必须离开美国后再度申请持F-1签证来新墨西哥大学学习
- G. UNM shall bill students directly for tuition, fees, medical insurance, books, supplies, and, if applicable, on-campus housing and meal plans. 新墨西哥大学直接收取学生学费,书本费,杂费,医疗保险费用,以及校内住宿及膳食费用。
- H.Students can research and enroll in UNM Campus Housing options at http://housing.unm.edu/once they have been admitted to UNM, but room availability is not guaranteed. Therefore, UNM will make good faith efforts as needed to help students obtain off-campus accommodation within reasonable proximity.

III. Financial and Billing Considerations 费用

IV. Term, Renewal, Amendment, Termination, and Dispute Resolution协议期限,续约,修订,终止和争议处理

- A. This Agreement shall become effective for an initial term of five (5) years from the date of the last signature by the parties' duly authorized representatives and shall automatically renew for successive five-year terms unless terminated as provided below.

- B. This Agreement may not be amended except by an instrument in writing signed by the duly authorized representatives of each party. 该协议经双方书面同意后才可以作修正或修改。
- C. Either party may terminate this Agreement by giving the other party at least 180 days' written notice, but any students who have been accepted at either institution at the date of termination may complete their courses of study in accordance with this Agreement. Termination shall be without penalty. 签约的任何协议方提前180天以上以书面形式通知对方后可以终止本协议。但是,本协议的终止不会影响现有从渤海大学已参加项目的学生,直至项目学习终止。
- D. This Agreement is signed in good faith and in accordance with the administrative rules and procedures governing each party. Therefore, any dispute that may arise concerning its interpretation and implementation will be resolved amicably through negotiations. 本协议是善意并按照双方行政管理规则签署。因此,可能出现的有关解释和执行的任何争议将通过友好协商解决。

V. Counterparts by Facsimile or Email

This Agreement may be executed in two or more counterparts, each of which together shall be deemed an original, but all of which together shall constitute one and the same instrument. In the event that any signature is delivered by facsimile transmission or by e-mail delivery of a ".pdf" format data file, such signature shall create a valid and binding obligation of the party executing (or on whose behalf such signature is executed) with the same force and effect as if such facsimile or ".pdf" signature page were an original thereof.

Any notice sent by email transmission shall be deemed to have been delivered at the time of confirmation of receipt by the addressee.
