**MEMORANDUM OF UNDERSTANDING ON
ACADEMIC AND CULTURAL COOPERATION
BETWEEN
CITY UNIVERSITY OF MACAU
AND
THE REGENTS OF THE UNIVERSITY OF NEW MEXICO, USA**

City University of Macau, located at Avenida Padre Tomás Pereira Taipa, Macau,
represented by its Rector, Professor Shu Guang Zhang,
and

The University of New Mexico, located at Scholes Hall Rm 144, Albuquerque, New
Mexico, USA 87131-0001, represented by its President, Professor Robert Frank,

Considering that both Universities share common interests and objectives in
academic and cultural fields;

Considering that both Universities are institutions that, by their nature, missions and
objectives, are called to establish channels of communication which permit the
exchange of scientific and cultural knowledge;

Now, therefore, the Universities join in the following memorandum of understanding
(Hereafter MOU) on academic and cultural cooperation.

Article 1

The two Universities agree in principle on the following objectives:

1. Intensifying their cultural and academic relations.
2. Promoting the development of mutual cooperation.
3. Developing exchange of academic and non-academic information and materials
in areas of common interest to both Universities.
4. Promoting teaching and research in areas of mutual interest.

5. Developing the exchange of students.
6. Promoting curricular development and faculty exchange.
7. Carrying out joint research projects.
8. Participating in academic seminars and conferences.

Article 2

The two Universities agree to explore specific areas of collaboration and prepare projects of academic cooperation in any areas of mutual interest. All the projects developed in the scope of this document must be determined by written mutual accord (addendum).

Article 3

All the issues emerging from implementation of joint academic projects must be negotiated and resolved between the two Universities case-by-case.

Any expenditures relating the execution of this document must be agreed upon and are subject to the approval of the Faculties, Schools, Institutes, or Departments involved.

Article 4

This MOU will become effective on the date of its signature and will be valid for a period of five (5) years, after which it will automatically renew for successive five-year periods unless terminated as provided below.

Article 5

Any alterations to this MOU must be effected in a writing signed by the parties' duly authorized representatives.

Article 6

This MOU can be terminated by either of the parties through an advance written notice of six (6) months. Termination of the MOU is subject to the completion of projects and activities in progress.

Article 7

All notices required hereunder shall be in writing and delivered by a duly authorized representative of the party giving the notice and sent by email transmission to the following addresses. Either party may change its email address for notice purposes by providing prior written notice to the other party. Any notice sent by email shall be deemed to have been delivered at the time of confirmation of receipt.
