## SUPPLEMENTARY AGREEMENT

Within the terms laid down by the agreement for co-operation between the University of New Mexico (USA) and the University of Granada (Spain), which has resulted in high scientific and academic rewards accruing to both universities, the parties concerned express their desire that henceforth, apart from extending and strengthening the joint activities presently being carried out, both universities shall make every effort to collaborate in the following areas:

1) Development of research in history, which the University of New Mexico will undertake via *The Latin American and Iberian Institute* and the University of Granada will pursue in its own corresponding departments and institutes.

2) Joint studies into the impact of processes of regional integration, to which the University of Granada will contribute its experience both in its role as an institution for higher education within the framework of the European educational system and as a leading university in the development of co-operative projects with Latin America.

3) Innovative technological projects which take advantage of the infrastructure afforded by the *Ibero-American Science and Technology Education Consortium (ISTEC)*, within which both universities play an important role.

## ACUERDO COMPLEMENTARIO

- 2) Realización de proyectos conjuntos sobre estudios del impacto de los procesos de integración regional, para los que la Universidad de Granada aportara la experiencia de la que dispone, tanto como institución superior integrada en el sistema educativo europeo, como en su papel de universidad líder en el desarrollo de proyectos de cooperación con países de Latino América.
- 3) Proyectos innovativos de carácter tecnológico, aprovechando la infraestructura que aporta el ISTECS (Ibero-American Science and Technology Education Consortium), en el que ambas instituciones desempeñan un importante papel.
